BACKGROUND CHECKS AND APPLICANT/EMPLOYEE INVESTIGATIONS

Advanced Security Systems seeks to maintain a safe workplace for employees who are honest, trustworthy, and non-violent and who do not otherwise present a risk of harm to their fellow employees, or others in the workplace.

As a result, we reserve the right to investigate, before hiring, an applicant's entire employment history, references, educational background, driving record, credit history, required licenses and/or certifications, and criminal record. Accordingly, all applicants for employment are requested to sign a request authorization, and consent for release of information form, and a release from liability form, and perhaps other similar documents, associated with the disclosure of information requested.

Advanced Security Systems reserves the right to exclude from consideration any applicant for employment who refuses to sign these forms, consistent with applicable law.

On occasion, Advanced Security Systems may deem it necessary to investigate current employees. This could occur where, due to behavior or other considerations, legitimate questions are raised concerning work performance, honesty, trustworthiness, reliability, or a potential threat to the safety of fellow employees, or others in the workplace. Therefore, an employee's credit history and/or criminal record may be investigated, for example, as well as his/her alcohol and drug use, which cold affect his/her job performance. Employees who are subject to such investigations are required to cooperate with our efforts to obtain such important information, failure to do so could result in discipline, up to and including discharge.

Request, Authorization, and Consent to Release Information to Advanced Security Systems and Release from Liability for Disclosure of Information

I understand that in connection with my application for employment, Advanced Security Systems may request information with regard to my employment history, references, educational background, driving record, credit history, required licenses and/or certifications, and criminal record. Before signing this form, I have read and I understand Advanced Security Systems' policy with regard to applicant background checks and employee investigations, as summarized at the top of this page. I have given Advanced Security Systems complete and truthful information with regard to my employment history, references, educational background, driving record, credit history, required licenses and/or employment application process and I understand that any material omissions or misrepresentations may result in the denial of my application, or the withdrawal of any employment offer.

Additionally, I understand that Advanced Security Systems may deem it necessary to investigate current employees. This could occur where, due to behavior or other considerations, legitimate questions are raised concerning work performance, honesty, trustworthiness, reliability, or a potential threat to the safety of fellow employees or others. Such investigations may include, but are not limited to, drug and alcohol testing, and/or an investigation of my criminal record and background generally. If I am the subject of such an investigation, I will be required to cooperate with Advanced Security Systems' effort to obtain important information, failure to do so could result in discipline, up to and including discharge.

In order to assist Advanced Security Systems in obtaining information and documents to confirm my
background, I hereby consent to the release of criminal records, Department of Motor Vehicles and other driving
records, credit reports, investigative consumer reports, and other similar documents.

It is understood that the results of a credit report and a background investigation generally will be used as part of an evaluation to help determine the success of my application for employment. These records will include all diplomas, degrees or other certificates conferred, grades earned, courses attende4d, and my academic records. This information is to be released and disclosed to Advanced Security Systems in connection with a background investigation relevant to my application for employment. My consent to the release and disclosure of this information applies only to Advanced Security Systems, its agents, officers, or employees. My consent is given on the condition that Advanced Security Systems will not disclose the information contained in my records to any other person or agency without my written consent.

I request, authorize, and consent to Advanced Security Systems representatives contacting the personal references identified in my application materials for the purpose of confirming the information contained therein as it applies to my employment application and otherwise furthers the Advanced Security Systems policy of conducting applicant background checks and employee investigations. I specifically request, authorize, and consent to Advanced Security Systems addressing verbal or written questions to those persons listed as my references about the information contained in my application, as well as my honesty, reliability, and potential tendency, if any, to engage in any sort of harmful, violent, unsafe, or threatening behavior.

Licensing or Certification Information

I request, authorize, and consent to the release and disclosure of information from any public agency or private entity concerning any professional or vocational license or certification that I have held in the past or currently hold, including, but not limited to, information concerning whether such license or certification is in good standing and any disciplinary or other proceedings concerning such licensure or certification.
